End of Service Contract Renewal Date:	The last date to extend or renew an existing Cisco Metacloud subscription.	November 7, 2018
End of Service Maintenance and Support Date:	The last date that Cisco Metacloud will support and may release any final software maintenance releases or bug fixes. After this date, Cisco Metacloud will no longer support, develop, repair, maintain, or test the product software.	November 10, 2019
