After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software. The only exception is Vulnerability/Security issues that will be addressed as shown in the End of Vulnerability/Security Support milestone below.	November 29, 2016
End of Vulnerability/Security Support: OS SW	The last date that Cisco Engineering may release bug fixes for Vulnerability or Security issues for IOS 15.6(1)S. After this date, bug fixes for Vulnerability or Security issues identified in IOS 15.6(1)S may be provided through later supported software releases. Note that there will be no rebuild releases of IOS 15.6(1)S provided after this End of Vulnerability/Security Support milestone date.	May 30, 2017
Last Date of Support: OS SW	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	May 31, 2021
