Cisco announces the end-of-sale and end-of-life dates for the Cisco Adaptive Security Appliance (ASA) Release 9.13(x), Adaptive Security Virtual Appliance (ASAv) Release 9.13(x) and Adaptive Security Device Manager (ASDM) Release 7.13(x). The last day to order the affected product(s) is June 22, 2020. Last Ship Date: App SW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	September 20, 2020
