Cisco announces the end-of-sale and end-of-life dates for the Cisco Nexus C93180YC-FX and C93108TC-FX Fixed Switches. The last day to order the affected product(s) is July 31, 2024. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin.
