



## End-of-Sale and End-of-Life Announcement for the Tidal Enterprise Orchestrator 2.1 NFR

Cisco announces the end-of-sale and end-of life dates for the Tidal Enterprise Orchestrator 2.1 NFR. The last day to order the affected product(s) is January 4, 2012. <b>Last Date of Support: App. SW</b>	The last date to receive service and support for the product. After this date, all support services for the product are unavailable, and the product becomes obsolete.	January 31, 2015
