

## End-of-Sale and End-of-Life Announcement for the Cisco Video Surveillance 750-GB Hard Drive

Cisco announces the end-of-sale and end-of life dates for the Cisco Video Surveillance 750-GB Hard Drive. The last day to order the affected product(s) is January 12, 2011. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.

The parts listed in this announcement have reached their end-of-sale and end-of-life stages as a result of an associated end of sales from the original parts manufacturers. The supply for these parts is being phased out worldwide as their availability becomes limited in the overall marketplace.

End-of-Life Announcement Date	The date the document that announces the end of sale and end of life of a product is distributed to the general public.	July 14, 2010
End-of-Sale Date	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	January 12, 2011
Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	April 12, 2011
End of Routine Failure Analysis Date: HW	The last-possible date a routine failure analysis may be performed to determine the cause of hardware product failure or defect.	January 12, 2012
